* Half Day programs are from 9:00 a.m. to 12:00 p.m. for Primary children.

** Extended Day programs are from 9:00 a.m. to 3:00 p.m. for Primary children over the age of four. Enrollment in Extended Day requires prior discussion with the child's teacher.

Plan A: Tuition must be paid in full by August 1, 2011

Plan B: Three payments due: August 1st, October 1st, and February 1st

Plan C: Ten post-dated checks due August 1st thru May 1st, which we will deposit on the first of each month

Plan D: Ten payments due: the first of each month from September 1st thru June 1st

DAWN -to- DUSK tuition is \$1015.00 per month DUE THE FIRST DAY OF EACH MONTH or as 10 post-dated checks. The Dawn-to-Dusk contract is based on a ten month tuition, September 1st thru June 1st (no discount will apply). Tuition for Dawn-to-Dusk summer program is separate from the 180 day school year.

There is a non-refundable registration fee of \$200.00 due upon submission of application.

I understand that students are admitted for the full academic year (180 days), and that my agreement to pay for the full academic year is not subject to change regardless of the reason for my child's absence.

ANNUAL GIVING

Annual giving is necessary to maintain the high standards of NWM. 100% participation is expected. We suggest each family to contribute a minimum of the equivalent of one months' tuition. This donation is tax deductible. A payment plan can be arranged.

FEES

Materials and activity fee for **elementary students** is due September 1, 2011 \$300.00 per year per student. Additional fees may be necessary for extended outings and the camp-out.

A one-time registration fee for new children of \$200.00, is NON-REFUNDABLE, and due upon submission of application.

There is a re-enrollment deposit of \$200.00 due March 15th for returning families. This deposit is non-refundable and is applied toward August tuition.

TUITION OBLIGATION SCHEDULE

If the student is withdrawn from the school for any reason, the obligation of the Parent(s)/ Guardian(s) will be calculated in accordance with the schedule below which sets out that obligation as a percentage of the total tuition due for the year. Charges will be assessed, or refunds calculated, based on this schedule:

A one month written notice sent to the office is required before withdrawing your child.

\$50.00 late fee will be charged for payments two weeks late.

\$25.00 late fee will be charged daily for any child picked up after their scheduled departure time.

\$25.00 fee will be charged for any returned check.
